

WAIVER AND RELEASE OF LIABILITY FOR MINORS

In consideration for permission to participate in any activity at The Airport Club, including the use of all child monitoring services and facilities offered at the club, today and on all future dates, I, for myself, and on behalf of the minor child identified above, our heirs, personal representatives and/or assigns, do hereby release, waive, discharge, and covenant not to sue The Airport Club, its directors, officers, owners, employees, independent contractors or agents (collectively referred to herein as the "Club"), from liability for any and all claims for personal injury, illness, death, property damage, or any other claim, including but not limited to claims arising out of the negligence of the Club or its agents. This waiver and release of liability applies to all Club activities, without limitation, regardless of whether participation requires the Participant to leave Club premises.

It is expressly agreed that participation in any and all Club activities, including but not limited to the use of the Club premises, without limitation and whether engaging in exercise or physical activities or not, shall be undertaken by the minor member or participant at his/her sole risk, and the Club shall not be liable for any injuries or any damages to any minor member or participant, or the property of any minor member or participant, or be subject to any claim, demand, damages or causes of action arising out of the use of, or occurring on, the Club's premises regardless of whether it was caused by the negligence of the Club. This waiver and release is intended to be as broadly interpreted as allowed under California law.

The undersigned understands and agrees that while using child monitoring services or otherwise on the premises of Club, regardless of the reason, ***on his or her own behalf and on behalf of any minor child being left with child monitoring staff***, it is being done at his or her own risk. The risk that the undersigned or any minor child may be exposed to COVID-19 or any other transmissible virus/disease/illness is specifically assumed – including exposure that may have been caused by the actions or inactions of employees or agents of Club. The Club shall not be liable for any injuries, damages or illnesses arising from exposure to COVID-19 or any other transmissible virus/disease/illness. The undersigned agrees he or she, as well as any minor child, will not sue Club for any illnesses, injuries or damages related to COVID-19 or any other transmissible virus/disease/illness, regardless of whether such exposure or transmission was caused by the negligence of Club or any of its employees or agents.

The Parent/Guardian executing this waiver and release of liability hereby agrees to hold the Club, its directors, officers, owners, employees, independent contractors and/or agents harmless from all claims which may be brought against them by or on behalf of any minor member or participant or any one of the their guests and to indemnify the Club from any such claims to the fullest extent allowed under California law.

The Parent/Guardian also expressly acknowledges that by signing below he or she is relinquishing all rights he or she may have to sue the Club for injuries arising out of the use of the Club facilities or its services that arise during the minor's use of and participation at the Club. The Parent/Guardian also acknowledges that he or she is relinquishing, on behalf of the minor children participating at the Club and using the Club facilities, all rights the child may have to sue the Club for injuries arising out of the use of the Club facilities or its services.
